Ladies and Gentlemen:

1. On March 25, 2013, El Paso Natural Gas Company, L.L.C. (El Paso) filed a request for an extension of a previous waiver granted in Docket No. RP12-606-000,<sup>1</sup> and a waiver of El Paso's tariff timing requirements for penalty credits to allow the Commission to determine final service rates in El Paso's system-wide rate case in Docket No. RP10-1398-000. For good cause shown, the Commission grants El Paso's waiver requests.
2. Section 14.2 of the General Terms and Conditions of El Paso's tariff requires El Paso to provide credits for penalties to be distributed to specified shippers no later than the March statement following the annual period (the previous calendar year). El Paso submits an annual penalty crediting report with the Commission with details of those penalty credits.
3. El Paso's currently-effective rates are subject to refund pending the outcome of the rate case proceeding in Docket No. RP10-1398-000. Because the final transportation service rates on which penalty credit calculations are based have yet to be determined, El Paso requested a waiver in Docket No. RP12-606-000. In the June 1 Order, the Commission granted El Paso's request for a waiver to delay: (1) the timing for issuance of penalty credits for April through December 2011; (2) the timing for issuance of cash-out revenue credits for January through December 2011; and (3) any penalty credits or

cash-out revenue credits required to be disbursed prior to when refunds are required in Docket No. RP10-1398-000.

4. El Paso states that, because the Commission's decision regarding the rate case proceeding in Docket No. RP10-1398-000 remains pending, El Paso requests that the Commission extend the waiver for 2011 credits granted in the June 1 Order. In addition, consistent with the June 1 Order, El Paso requests a waiver of the timing required for the issuance of penalty credits for calendar year 2012 because the rate levels for all services remain subject to refund pending the outcome of the Docket No. RP10-1398-000 rate proceeding. El Paso states that interest on the 2011 and 2012 credit amounts will accrue until such time as El Paso issues payment of final credit amounts.

5. El Paso requests these waivers to effectuate a delay for an additional year in the issuance of credits and the submission of a credit report. El Paso states that, should the Commission issue an order establishing a date for refunds prior to the timing requirement for issuing credits for the 2013 calendar year, El Paso will remit payment of the applicable credits (with the accrued interest amounts) no later than the shipper's next invoice after the date the Commission requires refunds. El Paso states that it will submit a penalty credit report within 45 days following the issuance of the credits.

6. Public notice of the filing was issued on March 23, 2013. Interventions and protests were due as provided in section 154.210 of the Commission's regulations (18 C.F.R. § 154.210 (2012)). Pursuant to Rule 214 of the Commission's Rules of Practice and Procedure (18 C.F.R. § 385.214 (2012)), all timely filed motions to intervene and any unopposed motions to intervene out-of-time before the issuance date of this order are granted. Granting late intervention at this stage of the proceeding will not disrupt the proceeding or place additional burdens on existing parties. No party filed a protest or adverse comments.

7. Consistent with the June 1 Order, the Commission finds it reasonable to grant El Paso's request for a one-year waiver extension of the 2011 credits and a one-year waiver of the 2012 credits, given the pendency of the rate case proceeding in Docket No. RP10-1398-000. Accordingly, for good cause shown, the Commission grants the requested waivers, as discussed above.
