Dear Ms. McNaul:

1. On December 1, 2011, you filed an Offer of Settlement and Settlement Agreement (Settlement) in the above-captioned proceeding as attorney for the City of Pasadena, California (Pasadena). On December 21, 2011, Commission Trial Staff filed comments in support of the Settlement.¹ On January 5, 2012, the Settlement Judge certified the Settlement to the Commission as uncontested.²
2. The Settlement resolves all issues set for hearing involving Pasadena's revised Base Transmission Revenue Requirement for the purposes of its participation in the California Independent System Operator Corporation as a participating transmission owner.³ The Settlement appears to be fair and reasonable and in the public interest, and is hereby approved.

3. If necessary, Pasadena shall calculate and make refunds consistent with the methodology set forth in the Settlement. Within thirty (30) days after making such refunds, Pasadena shall file with the Commission a compliance report confirming that it has provided refunds in accordance with the terms of the Settlement.

4. The Commission's approval of the Settlement does not constitute approval of, or precedent regarding, any principle or issue in this proceeding. The standard of review for modifications to the Settlement shall be the just and reasonable standard. The Commission retains the right to investigate the rates, terms and conditions under the just and reasonable and not unduly discriminatory or preferential standard of section 206 of the Federal Power Act, 16 U.S.C. § 824(e) (2006).

5. The revised tariff provisions submitted in e-Tariff reflect the rates established in the Settlement. Therefore, Pasadena has complied with *Electronic Tariff Filings*, Order No. 714, FERC Stats. & Regs. ¶ 31,276 (2008), and the revised tariff provisions are accepted.

6. This letter order terminates Docket Nos. ER11-4375-000 and ER11-4375-001. Upon receipt of the compliance refund report, a new sub-docket will be assigned in Docket No. ER11-4375.
