FERC's dam safety program has three principal components; the **Owner's Dam Safety Program (ODSP)**, the independent consultant's 5-year inspection, and the FERC's regulatory inspection and evaluation program. All three of these components are needed to successfully reduce the probability of dam failures.

Although there are many factors typically contributing to a given dam failure, the failure by the owner to carry out their dam safety responsibilities, either by neglect or organizational deficiencies, has been a factor in many failures starting with the Johnstown tragedy, Teton, and Taccoa Falls up to and including more recent failures such as Upriver Dam, Silver Lake, and Taum Sauk.

This workshop will focus on the reasons for the FERC Initiative and include lessons learned from ODSP submittals, past ODSP failures, and owner's success stories.
