As noted on Sheet No. 2A, the Old Regulatory Expense Surcharge is to expire on March 31, 1995, and the New Regulatory Expense Surcharge is to expire on October 31, 1995, subject to the terms of Article IV of said Stipulation. Unless otherwise changed pursuant to the Stipulation or upon the expiration of the rate moratorium described therein, Tarpon's maximum reservation charge will decrease to \$2.13, effective April 1, 1995, and to \$1.83, effective November 1, 1995, to reflect the expiration of the Old Regulatory Expense Surcharge and the New Regulatory Expense Surcharge.
