



Certificated Storage Projects Since 2000 for Expansion of or New Capacity

The table below list all FERC certificated natural gas storage projects that sought authorization to increase working gas capacity of an existing storage field or for the construction and operation new storage fields. Certificated projects are those in which the Commission has issued an order authorizing construction of the project. Please note that just because a project has been certificated, it does not mean that the project has been constructed and is currently in service. Further, full development of a project generally takes several or more years. Therefore, operational capacity may not equal certificated capacity for some time.

Information regarding the construction or in-service dates of projects is best obtained from the storage company. To view the order relating to any project, click the docket number in the table below.
