Message from Chairman Neil Chatterjee

Recent acts of brutality, hate, and even murder have painfully and clearly demonstrated the manner in which racism continues to blight our society. Over half a century has passed since the Civil Rights Act became law, and yet, it's deeply troubling that, too often, our black communities continue to face disparate treatment and our nation is still struggling under the immense weight of racism.

During these troubling times, I've reflected on my experience at the Historic Selma Pilgrimage earlier this year. As Americans, we have a flawed past and it's very clear we have more work to do decades later. As a parent, I've grappled with explaining these events to my children, while praying they will be part of a more accepting and socially responsible future.

I am also cognizant of the impact this has on our FERC community. I want to assure you of this: we at FERC have a common goal to keep our workplace free from prejudice and harassment in all its heinous forms. I am proud to be part of an agency that strives to create, and protect, a diverse and inclusive workforce. But given these recent events, I'm committed to work even harder to assure Commission employees they will be safe from racism and discrimination in their work environment.

To this end, in addition to our existing policies, I've worked with agency leaders and developed a comprehensive approach focused on providing FERC employees with this assurance. This approach initiates additional dialogue among Commission employees via focus groups and facilitated training. These discussions will be absolutely essential in gaining employee perceptions regarding the presence of diversity, inclusiveness, and discrimination within our ranks. In direct response to the feedback gleaned from these interactions, the Commission will formulate and implement actions to augment its current efforts to promote a diverse and healthy workforce culture.

I'm looking forward to engaging in this important process. I'm confident the collective efforts of the FERC workforce will help us maintain a safe and inclusive environment for all employees to thrive.
