

### **Getting Started**

You have spent a lot of time and effort preparing your document-getting it to the Commission should be easy. This guide is designed to take the guess work out of the filing process and help you submit your hydropower documents with ease.



#### **Create Your Account**

All filings related to hydropower projects should be filed electronically using the Commission's eFiling system unless otherwise directed in a letter or order issued by the Commission.

To eFile, you must first eRegister by going to https://ferconline.ferc.gov/eRegistration.aspx.
Once registered you may eFile at: https://ferconline.ferc.gov/eFiling.aspx



#### **Choose the Correct Filing Type**

Choosing the correct Filing Type helps the Commission route your filing to appropriate staff in a timely manner. Choose the menu option that best fits your filing.

#### **Include Project Numbers**

For existing Projects, the front page of all filings must include the Project number(s) (i.e. P-12345) to which the filing pertains. Applications for new Projects and Preliminary Permits will be assigned new Project numbers at the time of filing.




If your filing pertains to more than one Project, search and add all relevant Project numbers on the "Select Docket" screen in eFiling.

### Don't forget the subdocket

The subdocket is the three-digit number after the Project number (P-12345-678) and helps identify and group documents that pertain to a specific proceeding. You can find the subdocket of an ongoing proceeding on prior issuances in the same proceeding. Choose the subdocket that pertains to your filing when eFiling. New plans, amendment applications, or license applications should be filed under the "root" docket P-12345-000 and will be assigned a new subdocket. All dam safety documents should be filed under the root docket.

### How do I file Exhibit Drawings and GIS Data?

### How do I file CEII and Privileged Material?

CEII or Privileged material must be filed under the corresponding security classification tab in eFiling. Documents must be clearly marked with the applicable designation in bold font on the front page and each subsequent page. Each submission must include at least one public document which contains all of the public content of the filing with the CEII or Privileged material redacted or removed. Upload the public file under the 'Public' tab in eFiling.

## Do I ever need to provide paper copies?

While all hydropower documents should be filed electronically, you must also send paper copies of the documents listed below to the appropriate office as indicated. These paper copies must be exact duplicates of the eFiled document(s). Please place a coversheet on the paper copies indicating that the filing has been made electronically.

Send two paper copies of the following filings:

- Applications for Original, New, or Subsequent license under 18 CFR § 4.41, 4.51, 4.61, 5.17, 5.18
- Applications for Exemptions of 10MW or less under § 4.107
- Amendments to license applications under § 5.27
- All Pre-Application Documents (PADs) under § 5.6
