The Federal Energy Regulatory Commission (FERC) approach will be performed in accordance with the criteria set out in Consolidated Appropriations Act, 2010, (Pub. L. No. 111-117, § 743 (2009)), Appendix D of the November 5, 2010 OMB Memorandum on Service Contract Inventories, OMB Memorandum dated September 8, 2015, and will ultimately identify contracts for a more in-depth review.

FERC will develop the basic inventory in accordance with OMB guidance using FPDS-NG data to address a number of the inventory requirements consistent with the Consolidated Appropriations Act. The following special interest functions by Product Service Code (PSC) for contracts to be reviewed in response to the criteria required by Section 743 are: D307, R408, R414, and R707.

Planned analysis of FY 2015 Inventory

The Product Service Codes that will be evaluated next year in the FY 2015 analysis are: AD25 "Operational Systems Development", B510 "Study/Environmental Assessments", D307 "IT Strategy and Architecture", "D399 "Other ADP & Telecommunications Services", R408 "Program Management/Support", R410 "Program Evaluation/Review/Development", R414 "Systems Engineering Services", R424 Support – Professional Expert Witness", R706 "Logistics Support", S206 "Housekeeping – Guard", V229 "Public Transport Fare Media", and X299 "Lease-Rent of all other Non-Building Facilities", as these represent largest service contract obligations for FY 2015, as well as those PSCs considered to be Special Interest Functions (SIFs) as defined by OMB. The obligations are as follows:
