









### Final Report on February 2021 Freeze Underscores Winterization Recommendations

FERC, the North American Electric Reliability Corporation (NERC) and NERC's regional entities released the final report examining the impact of the February 2021 freeze on the bulk electric system in Texas and other parts of the South Central U.S. The 300-page analysis underscores preliminary recommendations released earlier this fall. The final report includes additional details regarding the need to strengthen rules for cold weather preparedness and coordination to prevent a recurrence of last winter's blackouts. 
#### Senate Confirms Willie Phillips as FERC Commissioner

The first meeting of the joint Federal-State Task Force on Electric Transmission took place on November 10. This important partnership between FERC and the National Association of Regulatory Utility Commissioners is a first-of-itskind effort to ensure important cooperation between federal and state regulators on electricity transmission-related issues. The Task Force will focus on topics related to planning and paying for transmission, including transmission to facilitate generator interconnection, that provides benefits from a federal and state perspective.
