



### FERC Transmission Proposal Addresses Planning, Cost Allocation



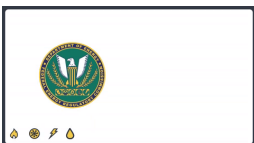

### FERC Approves Natural Gas Price Indices Policy

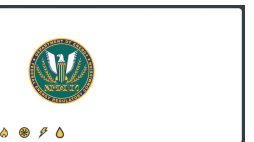

It largely adopts the proposal issued in [December 2020](#) to promote increased reporting of transactions to natural gas price index developers and improve the transparency requirements for those developers.
