



## FERC Revises NEPA Regulations and Provides Staff Guidance on Its Procedures

FERC voted unanimously on June 30, 2025, to revise its regulations on the implementation of the National Environmental Policy Act (NEPA) to remove references to the Council on Environmental Quality's (CEQ) regulations, which were rescinded in President Trump's Executive Order 14154 issued on January 20, 2025. FERC also issued staff guidance outlining its revised NEPA procedures.





#### FERC Acts to Remove Barriers to Building Natural Gas Facilities

The Commission, on June 18, 2025, <u>unanimously</u> <u>approved</u> four orders, including an immediate waiver of FERC's Order No. 871, to provide natural gas companies with increased flexibility and lessen regulatory burdens for certain activities related to their natural gas facilities.



#### Commissioners Hold Technical Conference on Resource Adequacy

The <u>two-day event</u> held on June 4 and 5, 2025, featured panelists from the Regional Transmission Organization (RTO)/Independent System Operator (ISO) regions, state regulatory Commissioners, and utilities. Participants discussed generic issues related to resource adequacy constructs, including the roles of capacity markets in the RTO and ISO regions that utilize them and alternative constructs in RTO/ISO regions without capacity markets.

FERC invites stakeholders to provide <u>post-conference comments</u> under Docket No. AD25-7-000. The deadline for comments is July 7, 2025.



#### Federal-State Current Issues Collaborative Meeting Announced

The <u>third meeting</u> of the Federal-State Current Issues Collaborative will be held on July 27, 2025, in Boston. A detailed agenda will be issued by July 11, 2025.
