Dear Ms. Spina:

1. On May 31, 2013, you filed revisions to Arizona Public Service Company's (APS) Reciprocal Transmission Service Agreement (Reciprocal Agreement) with PacifiCorp¹ pursuant to section 205 of the Federal Power Act (FPA).² On July 31, 2013, the Commission accepted the revisions to the Reciprocal Agreement, suspended them for a five-month period to become effective January 1, 2014, subject to refund, and established hearing and settlement judge procedures.³

2. On September 30, 2013, APS filed a motion to withdraw its revisions to the Reciprocal Agreement and terminate the proceeding. APS states that, following the Commission's July 31 Order, it engaged in bilateral discussions with PacifiCorp, which resulted in an agreement to terminate the Reciprocal Agreement and enter into a conforming Transmission Service Agreement for firm point-to-point transmission service (Replacement Agreement) under the APS Open Access Transmission Tariff, to be effective October 1, 2013. Thus, APS requests that the Commission grant its motion to withdraw the revisions to the Reciprocal Agreement effective October 1, 2013. APS also requests that the Commission waive answers to this motion because PacifiCorp is the only party that intervened in this matter and has agreed to the Replacement Agreement.

Subsequently, on October 2, 2013, the Chief Administrative Law Judge issued an order terminating the settlement judge proceedings.⁴

3. We grant APS's motion to withdraw its proposed revisions to the Reciprocal Agreement effective October 1, 2013 and terminate the proceeding. We note that PacifiCorp is the only party that intervened in this proceeding and APS states that PacifiCorp has agreed to terminate the Reciprocal Agreement and enter into the Replacement Agreement, rendering the proposed revisions to the Reciprocal Agreement moot.
